



## INFORMATION FOR 2026-2027 WRITERS GROUP GRANT

This is a professional development grant intended to help members of Saskatchewan writers groups develop their craft.

**Deadline: Monday June 22, 2026 at 4:30 pm.**

**Completed applications must be received by the SWG office by this deadline – late or incomplete applications will not be accepted.** If you are planning to mail your application to the office, please postmark by June 15 to ensure we receive it on time.

### **How to Submit:**

- 1) Complete an application package, which includes:
  - a. Group information
  - b. Direct Deposit Payment Form (if you've already submitted one on file, please just state that on your form)
  - c. Budget Request
  - d. Membership List
  - e. If your group has received funding in the last year, a follow up report must be sent **with** your application package.
  
- 2) Email all documents to [swgpr@skwriter.com](mailto:swgpr@skwriter.com), or mail them to the SWG Office at PO Box 3986, Regina SK S4P 3R9. If you mail your application to the SWG office, please notify staff to expect it.

### **Grant Amount**

Each writers group may apply for up to **\$750** for the fiscal year August 1, 2026 – June 21, 2027. If the group is approved for funding, you will be notified in August and payment will be issued September 2026.

All payments will now be made via direct deposit.

### **Criteria for Funding Eligibility**

A Saskatchewan writing group is eligible for funding if it meets the following criteria:

- a minimum of five active members
- two-thirds of the group are members of the SWG (membership must be renewed annually)
- group meets a minimum of five times per year to discuss writing by members
- members meet in order to develop their craft
- provided a follow-up report (with all the requested documentation) for the previous grant (if applicable).

### **Responsibilities of Groups Who Receive Grants:**

- include mention of SWG sponsorship on all appropriate publicity issued by the group
- provide follow-up reports with the next year's grant application, which includes copies of receipts or cheques as part of the follow-up report. Please see [Our How to Create a Follow-Up Report](#) document for more information about follow-up reports.

### **Acceptable Uses of the Grant**

Allowable expenses may include, but are not limited to, the following:

- fees to an author to offer a workshop (in-person or online)
- member travel expenses to allow them to attend meetings and craft development sessions
- member participation fees in conferences, workshops, and other craft development sessions
- critique manuscripts
- attend conferences or workshops (in-person or online)
- hold retreats
- attend author readings
- give readings locally/arrange Open Mics (i.e. cost of venue)
- writing exercises
- costs associated with holding writers group meetings (i.e. venue rental)
- fees for Zoom or other digital platforms that facilitate online writing group meetings

### **Restrictions**

The grant may **not** be used:

- for self-publication
- to buy books for the group
- for the costs of a website
- to promote the group or individual members
- for social events, food, alcohol, or party favours, and
- writing groups receiving a grant through this program are not eligible for funding to host readings through the Author Readings Program within the same grant period. Individual members may do readings through the Author Readings Program if they meet program eligibility.

### **Unspent Funds**

Any unspent grant money above the amount of \$50.00 must be returned to SWG by June 22, 2026. Groups are not entitled to purposefully hold back \$50.00 each year. For any unspent funds \$50.00 or under, please indicate how much is left over of your SWG funding and your intended use for it. The SWG encourages writing groups to spend their full funding amount.
